

Membership Terms & Conditions

Memberships

- 1. You must meet the requirements of membership appropriate to the category of membership you are applying for in order to be eligible for membership.
- 2. By submitting a new application for membership, or by renewing an existing membership, you are confirming that you have read, understood and agree to these Terms and Conditions.
- 3. Following successful application for membership and payment of any associated fees you will be able to access the benefits and services appropriate to your category of membership.
- 4. The categories of membership offered and the criteria for each different category of membership are available to view on our website, www.BIID.org.uk and may be amended from time to time.

Membership Fees and Subscription Year

- 5. Membership fees are determined by the BIID Council of Directors and are reviewed on an annual basis. Current membership fee rates can be found on the BIID website.
- 6. The membership subscription year runs from 1^{st} April to 31^{st} March each year.

Cancellation of Membership

 Members wishing to cancel their membership are members intending to resign must inform the Institute by 31st March. Failure to notify by this date will result in the full annual subscription fee being due.

Registered Interior Designer® Members have the option to contact us and reinstate your membership without the need to reapply for a period of up to two years from the date you have resigned or the end of the subscription year (31st March). After that period, you will be required to reapply and pay the application fee.

Refunding of membership fees

8. Subscription fees are non-refundable, either in full or in part.

Member logos and post nominal letters

- 9. BIID Registered Interior Designers®, BIID Registered Design Practice® members, International Dual Members, Associate members and Affiliate Members are all eligible to use the relevant BIID Member Logo for promotional purposes. Guidelines on logo use and access to these logos can be found in the BIID Member Area.
- 10. BIID Registered Interior Designers® are eligible to use the post nominal letters specified in the BIID RegID Guidelines on Logo Use, found in the Logo and Appellation section of the Member Area.
- 11. Student members, Provisional Members and Retired Members are not issued with BIID member logos or post-nominal letters.
- 12. No category of members is permitted to use the BIID logo without prior agreed permission.
