### 1. What is CPD?

Continuing Professional Development (CPD) enables professionals to maintain and enhance their knowledge and skills post-qualification. It is an essential component of professional practice, helping interior designers remain current with emerging materials, technologies, and best practices. CPD ensures:

- **Skill Enhancement:** Professionals refine their technical and creative skills to remain competitive in a rapidly evolving industry.
- **Regulatory Compliance:** Staying informed about changes in regulations, safety standards, and environmental sustainability practices.
- **Professional Integrity:** Demonstrating a commitment to personal and professional growth, which builds trust with clients and colleagues.
- **Career Development:** Supporting long-term career aspirations by fostering expertise and leadership capabilities.

To stay on top of your CPD requirements throughout the year, keep a dedicated folder (physical or digital) for tickets, receipts, and records. Schedule quarterly reminders to update your CPD tracker and utilise the BIID CPD Tracker in the Member Area.

- **Gaining Accreditation:** Fulfil requirements to achieve and maintain professional recognition.

Additionally, events hosted locally can be leveraged for context-specific learning.

### Industry-Wide Impact

The construction and built environment sectors recognise CPD as a foundation for professional development. Research indicates that **over 85% of built environment professionals** prioritise CPD to enhance industry competence and resilience (source: RICS Annual Review 2022).

By engaging in CPD, interior designers contribute to:

- **Higher Standards:** Ensuring quality and innovation in design.
- **Stronger Collaboration:** Enhancing interdisciplinary communication and teamwork.
- **Sustainability Goals:** Promoting environmentally responsible practices.

## 3. What is Your CPD Requirement?

All BIID Registered Interior Designers must complete and document **20 hours of CPD activities annually** (1st April to 31st March). This includes:

- **10 hours of structured CPD** (e.g., formal learning activities).
- **10 hours of unstructured CPD** (e.g., self-directed learning).

Structured activities are formal and planned learning experiences that often lead to tangible outcomes or certifications. Examples include:

- Attending live training sessions, courses, seminars, talks, or conferences.
- Participating in online events, such as webinars or e-learning modules.
- Teaching in formal settings, including developing and delivering educational content.
- Writing articles, manuals, or books for a professional audience.
- Completing academic courses or certifications related to interior design.

### Unstructured CPD Activities

Unstructured activities are self-directed and flexible, providing valuable learning experiences outside formal settings. Examples include:

- Visiting exhibitions and trade shows to explore new design trends.
- Reading industry-related journals, magazines, or books.
- Listening to podcasts or watching videos focused on interior design.
- Mentoring or coaching students or junior designers.
- Delivering talks or participating in panel discussions.
- Volunteering on BIID committees, council, or working groups.

### Exceeding the Minimum Hours

If you exceed the required 10 hours for structured or unstructured CPD, record all additional hours. There is no upper limit! Exceptional efforts may qualify for the **CPD Award** at the annual BIID AGM.

### Exemptions

- **Associate Members:** Exempt while pursuing Pathway Stages toward Registered Interior Designer status.
- **Retired or Non-Practicing Designers:** Exempt unless they return to active practice.
- **Late-Year Joiners:** Members joining after 1st October are exempt for the current cycle but must begin recording from 1st April of the next cycle.
- **Personal Circumstances:** Long-term illness or other extenuating situations reviewed on a case-by-case basis. Contact the BIID office promptly for support.

---

## 4. Duration of Educational Activities

There is no minimum duration for an activity to qualify as CPD. Activities can range from brief instructional videos to extensive academic courses. The key is that they contribute meaningfully to your professional development. For instance:

- A 15-minute podcast episode may count as unstructured CPD.
- A multi-day workshop may fulfil several structured CPD hours.

- **Member Area:** Access on-demand webinars, guides, and other resources tailored to interior designers.

### External Sources

- **Professional Bodies:** Events and courses offered by organisations like Royal Institute of British Architects (RIBA) or the Construction Industry Training Board (CITB).
- **Industry Publications:** Subscriptions to design journals or trade magazines.
- **Local and International Events:** Conferences, exhibitions, and trade shows relevant to your area of practice.
- **Online Learning:** Platforms like Coursera, LinkedIn Learning, and YouTube for skill-specific courses.

Many high-quality resources are free, such as webinars, podcasts, and publications.

## 6. Accepted Formats for CPD Records

You can record CPD activities using:

1. **BIID CPD Tracker:** Accessible online in the Member Area.
  2. **BIID CPD Tracker Template (Excel):** Request the latest version from the BIID office.
  3. **Personal Template:** Ensure it includes:
    - Date of completion
    - Activity name
    - Category (structured or unstructured)
    - Hours spent

## 7. Submitting Your Completed CPD Report

Submit your CPD report annually by the last business day of April. Save your summary as an Excel document and email it to [info@biid.org.uk](mailto:info@biid.org.uk) for approval. The BIID will:

- Review your submission for completeness and alignment with CPD requirements.
- Provide feedback if adjustments are necessary.

Extensions or exemptions for submissions are granted under exceptional circumstances. If you encounter challenges, contact the BIID office promptly for assistance.
